

# Selection of students who have received an overseas education program

## (Excerpt version)

### 1. Number of selected students

A few students.

### 2. Qualifications for applicants

Applicants must be Japanese nationals or holders of permanent resident status in Japan and meet one of the following conditions.

Other eligible applicants are those who do not have Japanese nationality but have "College Student" status of residence under the Immigration Control and Refugee Recognition Act, or those who are expected to obtain "College Student" status of residence at the time of admission to the university and meet one of the following conditions.

(1) Those who have completed or will complete 12 years of formal education in a foreign country, which is equivalent to a Japanese high school, for two years or more, and who have graduated or will graduate between April 2022 and March 31, 2025.

(2) Those who have continued their school education for two or more years in a foreign country in a 12-year course of study equivalent to a Japanese high school, and have been admitted to the third grade of a Japanese high school (including a post-secondary course), and have graduated or are expected to graduate from a Japanese high school between April 2022 and March 31, 2025.

(3) Those who have obtained one of the following qualifications in a foreign country after 2022.

a) International Baccalaureate degree awarded by the International Baccalaureate Office, a foundation based on the Swiss Civil Code

b) Abitur qualification recognized as a university entrance qualification in the states of the Federal Republic of Germany

c) Baccalauréat qualification recognized as a university entrance qualification in the Republic of France

d) General Certificate of Education Advanced Level (GCEA level) (at least three subjects in Mathematics, Physics, Chemistry, and Biology with a grade of "E" or better), recognized as a university entrance qualification in the United Kingdom

(4) Those who have completed or will complete a 12-year course of study from April 2022 to March 31, 2025, at an educational institution in a foreign country that has been accredited by an international evaluation organization (WASC, CIS, ACSI, NEASC, Cognia) for educational activities for at least 2 years of continuous schooling in a course corresponding to that of a high school.

(5) Those who have received accreditation from an international evaluation organization (WASC, CIS, ACSI, NEASC, Cognia) for their educational activities, have completed at least two years of continuous high school education at an educational institution in a foreign country, and have been admitted to the third grade of a Japanese high school (including the second semester of secondary school). The applicant must have graduated or be expected to graduate between April 2022 and March 31, 2025.

(Note 1) "Twelve years of schooling in a foreign country" means that the schooling must be based on the regular education system of the country where the school is located. Applicants who have completed an international school or an American school may apply as long as they meet the eligibility requirements from (3) to (5) above. If you have any questions about eligibility, please consult us before applying.

(Note 2) The period of study at an overseas educational institution that has been accredited or designated by the Ministry of Education, Culture, Sports, Science and Technology as having a course of study equivalent to that of a high school course, even if the school is located in a foreign country, does not count toward the "two years or more" requirement in Qualifications (1) and (2) above.

(Note 3) The University must receive the documents related to the application qualifications during the application period. Applicants who take the examinations after the application period or who take the examinations during the application period but do not receive their scores until after the application period are not eligible to apply.

### 3. Selection method

Selection will be made on the basis of an overall consideration of the results of comprehensive tests, interviews, and application documents.

Therefore, even if the total score of the comprehensive tests exceeds the minimum score required of successful applicants, it may not qualify for selection.

(Note 1) Comprehensive Test I is a descriptive test that mainly tests basic knowledge of science and mathematics (which is essential knowledge for receiving medical education at university), as well as logical thinking ability, and that includes questions in English.

Comprehensive Test II is a descriptive test that mainly tests logical and multifaceted thinking and expressiveness.

(Note 2) The University Admission Common Test is not required.

(Note 1) The result of the interview (60 points allotted) will be utilized in the overall evaluation.

(Note 2) Application documents will be utilized for the overall evaluation. They will not be scored.

Saturday, October 12, 2024.

### 8. Others

(1) In principle, classes are conducted in Japanese.
